

**Regular Meeting  
February 25, 2019**

**CALL TO ORDER**

The regular meeting of the Bradley Village Board was called to order on Monday, February 25, 2019 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustee's Redmond, Gadbois, Watson, Barber and Allen. Trustee Balthazor was absent.

**AGENDA**

Trustee Gadbois added a 13 2 under Unfinished Business KRMA Report  
A motion was made by Trustee Allen and seconded by Trustee Gadbois to approve the agenda with the changes (5 ayes 0 nays) Motion carried

**PRESENTATION OF MINUTES**

A motion was made by Trustee Gadbois and seconded by Trustee Redmond to approve the minutes of the February 11, 2019 as printed and presented. (5 ayes 0 nays) Motion carried

**PRESENTATION OF COMMUNICATION**

Mayor read a letter from Dr. Scott Goselin Superintendent of the Bradley School District 61. The letter was informing the Board and the public on the Referendum that will be before the voters in the School District on April 2, 2019. It is a \$ 10 million proposal for Air Conditioning and Building Improvements.

Chief Eggert wanted to give out Certificates of Recognition to two Police Officers and two Firefighter Paramedics who saved the life of a one-year-old child at Aldi's. Officers were August LeBeau and Timothy Williams. Firefighter Paramedics were Michael McCue and Andy Przybyla all four received Certificates.

Chief Johnston wanted to recognize Misty Kerouac a Telecommunicator who has 10 years of service to the Village of Bradley.

Chief gave an update on the recent robberies in the Village. Both subjects in the armed robberies were apprehended, Boost Mobile and a shooting at 1300 Inglesh Drive.

## **UNFINISHED BUSINESS**

Discussion of Ordinance O-1-19-1 (Home Kitchen Operations) being sent back to committee or returned to March 11, 2019 Agenda.

A motion was made by Trustee Watson and seconded by Trustee Allen to put O-1-19-1 on the March 11, 2019 Agenda.

Trustee Gadbois stated she would like to see two items be included in the Ordinance one

- They become a Registered Business in the Village of Bradley
- Anyone that wants to comply with the Home Kitchen Act take a food safety course

Trustee Watson stated he would like to see only one stipulation that they become a Registered Business in the Village of Bradley. Administrator Wojnarowski went over the requirements that are included in the Ordinance. The Mayor stated he would like to see this go back to Committee to get it "right the first time." Trustee Watson made an amendment to his motion of putting it on the agenda, he would like to simply state that the Ordinance will comply with

the Home Kitchen Act and the only requirement is to register as a Business within the Village of Bradley. Trustee Allen seconded the amendment.

(3 ayes Trustee Watson, Barber & Allen 2 nays Trustee Gadbois & Redmond)

KRMA update – Mayor Adams stated the Attorney for KRMA was to be present at the meeting. He had a family emergency and was unable to attend. He will be at the March 11, 2019 meeting to answer any questions about KRMA. The only stipulation is he will not answer any questions that have to do with litigations.

### **NEW BUSINESS**


Mayor had two appointments Police & Fire Pension Funds. Mayor is appointing our Treasurer/ Finance Director Rob Romo to each Pension Fund.
