The regular meeting of the Bradley Village Board was called to order on Monday, March 11, 2019 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustee's Balthazor, Redmond, Gadbois, Watson, Barber and Allen, all were present.

O-1-19-1 an Ordinance adding a new Division 6 (Home Kitchen Operations) to Chapter 12 (Business Regulation), Article IV (Specific Businesses of the Village Code. (2nd reading)

A motion was made by Trustee Watson and seconded by Trustee Barber to approve O-1-19-1

Discussion - Trustee Gadbois asked that there be comments added to the Ordinance.

1. Need to register for a Business License.
2. Need to take a Sanitation Class and be certified.

Trustee Watson stated he would modify his motion to have these stipulations/classifications added to the Ordinance seconded by Trustee Barber. (3 ayes 4 nays) Mayor voted, Motion failed.

O-3-19-1 an Ordinance Granting a Special Use Permit for Certain Property (380 S. Schuyler Ave.) within the Village of Bradley, Kankakee County Illinois. (1st reading)

A motion was made to waive the two readings by Trustee Watson and seconded by Trustee Redmond (7 ayes 0 nays) Mayor voted, Motion carried.

A motion was made to approve O-3-19-1 by Trustee Redmond and seconded by Trustee Gadbois (6 ayes 0 nays) Motion carried.

Trustee Redmond set an Ordinance Committee meeting for Thursday, March 21, 2019 at 5:00 p.m. on the Agenda will be the Home Kitchen/Cupcake Ordinance.

LICENSE, ZONING, PLANNING & GRANTS

Trustee Barber had no report.

UNFINISHED BUSINESS

Mayor read a report that was given to him by the KRMA Attorney regarding KRMA.

Trustee Watson had questions.

1. Can KRMA sue or be sued, can each Municipality be sue or sued?
2. How far does this go back, Mayor stated he cannot discuss how far because of the potential ligation involving KRMA.
3. Do KRMA Board Members approve checks? Mayor there are two Board Member signatures per check and they receive Accounts Payable list of all invoices.

Trustee Gadbois asked the Board could start receiving Quarterly reports, Mayor responded yes.

Collections Contract – Finance Director Romo presented the Municipal Collection Services, Inc contract that was recommended by the Insurance and Finance Committee.

A motion was made by Trustee Barber and seconded by Trustee Gadbois to accept the contract. (6 ayes 0 nays) Motion carried
