**ORDINANCE NO. O-9-17-1**

**AN ORDINANCE REGULATING PARKING ALONG NORTH STREET BETWEEN  
PIERCE AVENUE AND CARDINAL DRIVE IN THE VILLAGE OF BRADLEY,  
KANKAKEE COUNTY, ILLINOIS**

**WHEREAS**, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to 65 ILCS 5/11-80-2 of the Illinois Municipal Code, the Village has the authority to regulate the use of streets and roadways within the Village; and

**WHEREAS**, pursuant to 625 ILCS 5/11-208 of the Illinois Vehicle Code, the Village has the authority to regulate the standing or parking of vehicles over and upon streets and roadways within the Village; and

**WHEREAS**, the Village of Bradley (“Village”) has entered into an Intergovernmental Agreement with the State of Illinois, by and through the Illinois Department of Transportation (“IDOT”), for the purpose of replacing the North Street Bridge at I-57 (FAI Route 57, State Section (46-3) HBR) and other related work (collectively the “Bridge Project”);

**WHEREAS**, as part of said Agreement, the Village agreed to restrict parking over certain portions of North Street between Peirce Avenue and Cardinal Drive;

**WHEREAS**, the Village President and Board of Trustees have determined that restricting parking along certain portions of North Street between Peirce Avenue and Cardinal Drive is in the best interests of the citizens of the Village of Bradley.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That in order to promote the health, safety, and welfare of the citizens of the Village of Bradley, Kankakee County, Illinois, parking is hereby prohibited on both sides of such part North Street as extends from Station 100+62.17 to Station 103+34.83 between Peirce Avenue and Cardinal Drive in the Village of Bradley. Such part of North Street is commonly known as the North Street bridge and the bridge approach pavements (30 feet on each side of the bridge’s abutments).

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent

jurisdiction, such adjudication shall in no way effect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


