RESOLUTION NO. R-5-18-1

**A RESOLUTION AUTHORIZING THE HIRING OF FOUR SEASONAL WORKERS
FOR THE PUBLIC WORKS DEPARTMENT FOR THE PERIOD MAY 15, 2018
THROUGH SEPTEMBER 30, 2018.**

WHEREAS, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Village of Bradley (“Village”) has need from time to time in its various departments (i.e. Police, Public Works) for the addition of seasonal workers to supplement the regular departmental workforce; and

WHEREAS, the Village’s Public Works Department requires the addition of four seasonal workers to assist in various park maintenance, watering landscape, painting curbs and other basic functions not typically reserved for full time employees from approximately May 15, 2018 through September 30, 2018; and

WHEREAS, the seasonal workers will not be full-time employees for purposes of the Affordable Care Act due to the term of their employment; and

WHEREAS, the Village President and Board of Trustees have determined that the hiring of the four seasonal employees for work assignments within the Public Works Department for the period specified in this preamble is in the best interests of the citizens of the Village.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS CONSTITUTIONAL AND STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That the President and Board of Trustees of the Village of Bradley hereby authorize the hiring of four seasonal workers for work assignment in the Public Works Department from May 15, 2018 to September 30, 2018.

SECTION 3. Compensation for the seasonal workers will be limited to an hourly wage paid at a rate of \$10.00, per hour, subject to overtime pay and conditions of employment required under federal and state law, with no further benefits to be extended to the seasonal workers.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way effect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 6. That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 7. That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
