RESOLUTION NO. R-9-18-2

A RESOLUTION TO ABATE THE SEWER DEBT SERVICE PORTION OF THE PROPERTY TAX LEVY BEGINNING IN DECEMBER OF 2018 IN THE EVENT THE VILLAGE ADOPTS AN ORDINANCE IMPOSING A SIMPLIFIED MUNICIPAL TELECOMMUNICATION TAX

WHEREAS, The President and Board of Trustees for the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions that pertain to its governmental affairs; and

WHEREAS, the Village of Bradley is contemplating adopting an Ordinance imposing a simplified Municipal Telecommunications tax; and

WHEREAS, in the event the Village Board adopts an Ordinance imposing a simplified Municipal Telecommunication Tax, it is the intention of the Village Board to abate the sewer debt service portion of the property tax levy, beginning in December 2018, and to continue said abatement while an Ordinance imposing a simplified Telecommunication Tax Ordinance exists.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. The President and Board of Trustees hereby find that all of the recitals contained in the preamble of this Resolution are true, and reflect the intent of the Board, and as such are adopted hereto and made part hereof.

Section 2. That the President and Board of Trustees of the Village of Bradley hereby express their intent to abate the sewer debt service portion of the property tax levy beginning with a December 2018 levy abatement, and to further continue said abatement while an Ordinance imposing a simplified Municipal Telecommunication Tax Ordinance exists.

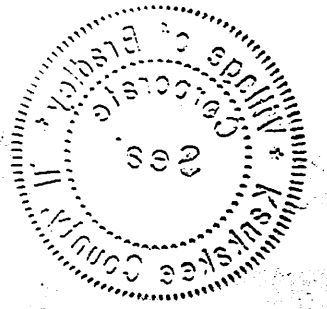

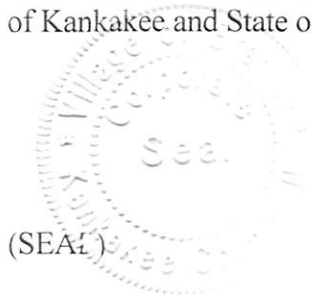
