**ORDINANCE NO. O-3-19-2**

**AN ORDINANCE ADDING A NEW DIVISION 6 (HOME KITCHEN OPERATIONS) TO  
CHAPTER 12 (BUSINESS REGULATION), ARTICLE IV (SPECIFIC BUSINESSES) OF  
THE VILLAGE CODE**

**WHEREAS**, the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, Section 3.6 of the Illinois Food Handling Regulation Enforcement Act (410 ILCS 625/3.6) (the “Act”) permits the Village to authorize Home Kitchen Operations (as therein defined) by ordinance; and

**WHEREAS**, the Corporate Authorities of the Village desire to authorize Home Kitchen Operations as permitted by the Act and in the manner set forth below; and

**WHEREAS**, the Corporate Authorities of the Village have determined that authorizing Home Kitchen Operations as set forth in this Ordinance is in the best interests of the Village and its citizens.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That a new Division 6 (Home Kitchen Operations) is hereby created within Chapter 12 (Business Regulation), Article IV (Specific Businesses) of the Village Code, as follows:

**Sec. 12-232. – Home Kitchen Operations Authorized; Registration Required;  
Educational Requirements.**

- (a) For the purposes of this Division, “Home Kitchen Operation” shall have the same meaning as in the Illinois Food Handling Regulation Enforcement Act (410 ILCS 625/0.01, *et seq.*), as amended.
- (b) The Village of Bradley hereby adopts and incorporates any and all provisions of the Illinois Food Handling Regulation Enforcement Act as are applicable to Home Kitchen Operations.
- (c) Home Kitchen Operations are permitted in the Village of Bradley.

(d) No Person shall operate and/or conduct the business of a Home Kitchen Operation within the Village unless they first:

- i. Register their Home Kitchen Operation with the Village Clerk; and
- ii. Present the Village Clerk with a valid, unexpired certificate issued to the Person upon successful completion, including any testing component, of either (1) a Certified Food Protection Manager education course or (2) any other food safety education course that the Village determines, in its sole discretion, to be substantially similar to and equivalent with such a course, considering the topics covered, the length of the course, and/or any state or federal approval or accreditation associated therewith.

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.



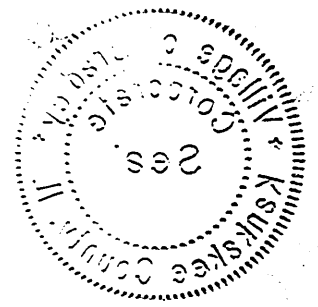
