(BRADLEY SQUARE SHOPPING CENTER)**

**WHEREAS**, the Village of Bradley (“Village”) is an Illinois municipal corporation, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

**WHEREAS**, pursuant to 625 ILCS 5/11-209, the Village is authorized and empowered to enter into agreements with private entities to enforce traffic regulations upon privately owned parking lots falling within the jurisdiction of the Village; and

**WHEREAS**, the Village recognizes the need to enforce parking regulations upon the Bradley Square Shopping Center parking lot;

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Bradley, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein by reference as though fully set forth.

**Section 2. Execution of Agreement.** The Village President and Village Clerk are hereby authorized to sign, execute and deliver the agreement known as the Parking Lot Agreement, as attached.

**Section 3. Severability and Repeal of Inconsistent Ordinances and Resolutions.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing resolutions of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval as provided by law.


