A RESOLUTION APPROVING THE COLLECTIVE BARGAINING AGREEMENT WITH THE LABORERS' INTERNATIONAL UNION OF NORTH AMERICA, LOCAL 751 (CODE UNIT)

WHEREAS, the Village of Bradley desires to provide efficient and effective code services for the citizens and residents of the Village;

WHEREAS, the Village's code staff are members of the Laborer's International Union of North America, Local 751 ("Local 751"), which acted as bargaining agent for them;

WHEREAS, Local 751 has tendered a reasonable agreement; and

WHEREAS, the Village has examined said agreement and deems it fair and reasonable.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.

Section 2. Collective Bargaining Agreement Approved. The Collective Bargaining Agreement with the Laborers' International Union of North America, Local 751, dated May 1, 2016 through April 30, 2021 as presented with this Resolution (Exh. A) is approved.

Section 3. Severability and Repeal of Inconsistent Resolutions. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. Effective Date. This Resolution shall take effect from and after its adoption and approval.
