

ORDINANCE NO. O-11-16-5_____

ORDINANCE ABATING A PORTION OF THE TAX HERETO LEVIED FOR THE YEAR 2016 TO PAY THE PRINCIPAL OF AND INTEREST ON \$4,475,000 GENERAL OBLIGATION SEWERAGE REFUNDING BONDS (ALTERNATE REVENUE SOURCE), SERIES 2015A, OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS.

WHEREAS, the President and Board of Trustees (the "*Board*") of the Village of Bradley, Kankakee County, Illinois (the "*Village*"), by Ordinance Number 0-7-15-6, adopted on the 10th day of August, 2015 (as supplemented by a notification of sale of bonds dated August 26, 2015, the "*Ordinance*"), did provide for the issue of \$4,475,000 General Obligation Sewerage Refunding Bonds (Alternate Revenue Source), Series 2015A (the "*Bonds*"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, the Pledged Revenues (as defined in the Ordinance) have been deposited into the Junior Bond and Interest Account (as defined in the Ordinance) in an amount sufficient to pay debt service on the Bonds; and

WHEREAS, the Village will have sufficient funds available to pay \$49,450 of the principal and interest on the Bonds for so as to enable the abatement in the amount of \$49,450 of the taxes to be levied for the 2016 tax year pursuant to Section 16 of the Ordinance; and

WHEREAS, it is necessary and in the best interests of the Village that the tax heretofore levied for the year 2016 to pay the principal of and interest on the Bonds be partially abated in the amount of \$49,450 and that a tax be levied for the year 2016 to pay principal and interest on the Bonds in the amount of \$400,550.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2. Abatement of Tax. The tax heretofore levied for the year 2016 in the Ordinance is hereby partially abated in the amount of \$49,450 as the Village has sufficient funds available to pay \$49,450 in principal and interest on the Bonds pursuant to Section 16 of the Ordinance.

Section 3. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of the County of Kankakee, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2016 in accordance with the provisions hereof.

Section 4. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provisions of this Ordinance. All existing ordinances of the Village are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

Section 5. Effective Date. This ordinance shall be in full force and effect forthwith upon its passage by the Board and signing and approval by the President.

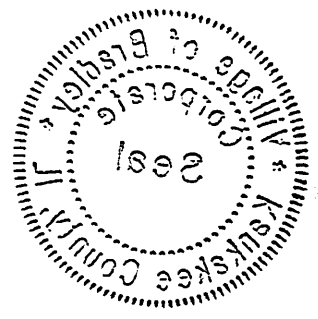

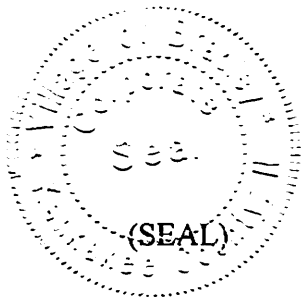
