

RESOLUTION NO. R-12-16-1

A RESOLUTION FOR THE MAINTENANCE OF STREETS AND HIGHWAYS BY THE
VILLAGE OF BRADLEY UNDER THE ILLINOIS HIGHWAY CODE

WHEREAS, pursuant to Article 7 (“Municipal Administration of Streets”), Division 2 (“Use of Motor Fuel Tax Funds”) of the Illinois Highway Code, 605 ILCS 5/7-202, *et. seq.*, the Village of Bradley, Kankakee County, Illinois (“Village”) may use Motor Fuel Tax Funds for the purposes set forth therein; and

WHEREAS, pursuant to the applicable provisions of the Illinois Highway Code, the Village hereby appropriates the amount of Motor Fuel Tax Funds set forth in this Resolution for the Calendar year beginning on January 1, 2017, and ending on December 31, 2017.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, BY AND PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. That the President and Board of Trustees hereby finds that all of the recitals contained in the preamble to this Resolution are true, correct and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That the Village hereby appropriates the sum of Seven Hundred and Seventy-Five Thousand Dollars and 00/100 (\$775,000.00) of Motor Fuel Tax Funds for the purpose of maintaining streets and highways under the applicable provisions of the Illinois Highway Code for the calendar year beginning on January 1, 2017, and ending on December 31, 2017.

SECTION 3. That only those streets, highways, and operations listed and described on the Village’s Municipal Estimate of Maintenance Costs, including any and all supplemental or revised estimates approved in connection with this resolution (attached hereto as “Group Exhibit A” and fully incorporated herein), are eligible for maintenance with the Motor Fuel Tax Funds appropriated hereby during the period set forth in Section 2 above.

SECTION 4. That the Village Clerk, or his designee shall, as soon as practicable after the close of the period set forth in Section 2 above, submit to the Illinois Department of Transportation (“Department”), on forms furnished by said Department, a certified statement showing expenditures from and balances remaining in the accounts for the period set forth in Section 2 above.

SECTION 5. That the Village Clerk shall immediately transmit two (2) certified copies of this Resolution to the District office of the Department, located in Ottawa, Illinois.

SECTION 6. That in the event that any section, paragraph, clause, or provision of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the

remaining sections, paragraphs, clauses, or provisions of this Resolution that may be given effect without such invalid or unenforceable section or sections, paragraph or paragraphs, clause or clauses, or provision or provisions.

SECTION 11. That all resolutions, ordinances, motions, or parts thereof conflicting with any of the sections, paragraphs, clauses, or provisions of this Resolution shall be and are hereby repealed to the extent of the conflict.

SECTION 12. That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 18. That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
