

**Regular Meeting
January 28, 2019**

CALL TO ORDER

The regular meeting of the Bradley Village Board was called to order on Monday, January 28, 2019 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustee's Balthazor, Redmond, Watson, Barber and Allen. Trustee Gadbois was absent due to a death in the family

AGENDA

Mayor added 6 B a letter from Republic Services.

Trustee Redmond deleted 12 E Ordinance O-1-19-1 Home Kitchen Operations, he removed it until we get an opinion from the Illinois Attorney General.

A motion was made by Trustee Balthazor and seconded by Trustee Redmond to approve the agenda with the changes (4 ayes 0 nays 1 absent 1 abstain- Trustee Allen) Motion carried

UTILITIES/EXPANSION

PUBLIC WORKS & PARKS

Trustee Balthazor report is combined with Trustee Watson's report.

Mayor asked the public to be aware to move their vehicles off the main streets so they can plow curb to curb. The vehicles that are not moved will be tagged and receive notification to move. If vehicles are not moved then they will be towed.

POLICE & FIRE

There was no report under Police as Trustee Gadbois was absent.

Fire Department December 2018 Report. Chief Eggert was present he gave the Report for the month of December 2018 and it will be on the website. Chief Eggert gave a presentation and read a list of staff who had 5, 10 and 15 years on the Department. Present at the meeting was Lt. Steve Trnka, Lt. Eric Dockus and Captain Kevin Goudreau they were presented with 25-year pins, also present was Captain Greg Glidewell who was presented with a 30-year pin.

Chief Johnston made a presentation to Dr. Joe Abrassert from the Kankakee Animal hospital, he was the primary care vet for K9 Pato. Chief presented Dr. Joe with a plaque.

Present from the NAACP were Theodis Pace and Steve Hunter. They were present because the Bradley Police Department and the NAACP are adopting and sharing the NAACP 10 Shared Principals. This is to improve Community Relations between the NAACP and the Police Department in the event of an unfortunate incident, a plaque with the 10 Shared Principals on it was presented to the NAACP.

Chief wanted the public know that Wednesday, Thursday and Friday the Village hall will be a warming center.

A motion was to adopt O-1-19-4 by Trustee Balthazor and seconded by Trustee Watson (4 ayes 1 abstain Trustee Allen 1 absent Trustee Gadbois) Motion carried
