

**Regular Meeting
March 25, 2019**

CALL TO ORDER

The regular meeting of the Bradley Village Board was called to order on Monday, March 25, 2019 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustee's Balthazor, Redmond, Gadbois, Watson, Barber and Allen. All Trustees were present.

AGENDA

A motion was made by Trustee Allen and seconded by Trustee Barber to approve the agenda on a unanimous aye vote.

PRESENTATION OF MINUTES

ORDINANCE & TECHNOLOGY/BUILDING CODE

A motion was made to approve O-3-19-2 by Trustee Redmond and seconded by Trustee Gadbois (6 ayes 0 nays) Motion carried

O-3-19-3 an Ordinance authorizing the Sale and/or Disposal of certain Personal Property that is no longer necessary or useful for the Village's Public purposes (1st reading)

A motion to waive the two readings was made by Trustee Allen and seconded by Trustee Barber. (7 ayes 0 nays) Mayor voted, Motion carried.

A motion was made to approve O-3-19-3 by Trustee Watson and seconded by Trustee Redmond (6 ayes 0 nays) Motion carried

NEW BUSINESS

A motion was made to adopt R-3-19-2 by Trustee Watson and seconded by Trustee Gadbois. (6 ayes 0 nays) Motion carried
