ORDINANCE NO. O-5-19-1

AN ORDINANCE AMENDING CHAPTER 2 (ADMINISTRATION), ARTICLE II (BOARD OF TRUSTEES), DIVISION 1 (GENERALLY), SECTION 2-27 (COMMITTEES) OF THE VILLAGE CODE OF BRADLEY

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities of the Village of Bradley previously established certain standing committees of the Village Board by ordinance; and

WHEREAS, the Corporate Authorities of the Village of Bradley have determined that it is in the best interests of the Village and its Citizens to update the standing committees of the Village as set forth in this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That Chapter 2 (Administration), ARTICLE II (Board of Trustees), Division 1 (Generally), Section 2-27 (Committees) of the Village Code is hereby amended to read as follows:

Sec. 2-27. - Committees.

- (a) The following shall be the standing committees of the board of trustees:
- (1) Public Works: Streets, Utilities, Sewer, Infrastructure;
 - (2) Parks/Community Events;
 - (3) Public Safety: Fire and Police;
 - (4) Administration: Insurance, Finance, Human Resources;
 - (5) Information Technology/Innovation/Performance Improvement: IT, Community Outreach, Marketing; and
 - (6) Community Development: Code Enforcement, Planning and Zoning, Economic Development.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
