



BRADLEY POLICE DEPARTMENT REGISTRATION REQUIREMENTS



IF YOU ARE A SEX OFFENDER, CHILD SEX OFFENDER, OR SEXUAL PREDATOR REGISTRANT:

- ✘ Notify Police ***IN PERSON*** within three (3) days of any registration changes.
- ✘ Stop by Bradley Police station or call (815) 933-3315 to set up an appointment to register.
- ✘ Registration hours are from 9:00 am to 5:00 pm, Monday-Friday, excluding Holidays.
- ✘ If no one is available to register, then notify the dispatcher you made an attempt to register by leaving you name, date of birth, and contact information, such as a telephone number.
- ✘ At registration, bring in current driver's license or state ID card for proof of residency along with lease, rental agreement and/or utility bill.
- ✘ A fee of \$100.00 for initial registration and \$100.00 for annual renewal fee will be collected per state statute.

REGISTRATION REQUIREMENTS

IF YOU ARE A MURDERER OR VIOLENT OFFENDER AGAINST YOUTH REGISTRANT:

- ✘ Notify Police ***IN PERSON*** within five (5) days of any registration changes
- ✘ Stop by Bradley Police station or call (815) 933-3315 to set up an appointment to register.
- ✘ Registration hours are from 9:00 am to 5:00 pm, Monday-Friday, excluding Holidays.
- ✘ If no one is available to register, then notify the dispatcher you made an attempt to register by leaving you name, date of birth, and contact information, such as a telephone number.
- ✘ At registration, bring in current driver's license or state ID card for proof of residency along with lease, rental agreement and utility bill.
- ✘ A fee of \$100.00 for initial registration and \$100.00 for annual renewal fee will be collected per state statute.
