

A RESOLUTION AUTHORIZING THE VILLAGE OF BRADLEY TO EXECUTE THE ILLINOIS DEPARTMENT OF TRANSPORTATION ROUTE 50 SHARED PATH LOCAL AGENCY AGREEMENT FOR FEDERAL PARTICIPATION

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Authorization. The President and Board of Trustees of the Village of Bradley do hereby authorize the President of the Village of Bradley to execute the attached Illinois Department of Transportation Route 50 Shared Path Local Agency Agreement for Federal Participation (hereinafter the "Agreement"), as attached hereto as Exhibit A.

Section 2. Appropriation. By execution of the Agreement, the Village is indicating sufficient funds have been set aside to cover its share of the project cost, currently approximately \$69,000.00, and additional funds will be appropriated, if required, to cover the Village's total cost.

Section 3. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All existing ordinances and resolutions of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Resolution.

Section 4. Effective Date. The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.
