

RESOLUTION NO. R-7-16-4

A SUPPLEMENTAL RESOLUTION FOR MAINTENANCE OF STREETS AND HIGHWAYS BY THE VILLAGE OF BRADLEY UNDER THE ILLINOIS HIGHWAY CODE


NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Bradley, as follows:

Section 1. Appropriation of Funds. There is hereby appropriated the additional sum of \$15,000.00 of Motor Fuel Tax (MFT) funds for the purpose of maintaining streets and highways under the applicable provisions of the Illinois Highway Code from January 1, 2016 to December 31, 2016.

Section 2. Eligibility. Be it further resolved, that only those streets, highways, and operations as listed and described on the approved Municipal Estimate of Maintenance Costs, including supplemental or revised estimates approved in connection with this Resolution, are eligible for maintenance with MFT funds during the period as specified above.

Section 3. Clerk to Certify and Forward. Be it further resolved that the Clerk shall, as soon as practicable after the close of the period as given above, submit to the Department of Transportation, on forms furnished by said Department, a certified statement showing expenditures from and balances remaining in the account(s) for this period, and the Clerk shall immediately transmit two certified copies of this Resolution to the district office of the Department of Transportation, at Ottawa, Illinois.

Section 4. Effective Date. This Resolution shall take effect from and after its adoption and approval.




