Subject: **Request for Child Day Care Information**

The Bradley Police Department has sent this letter to you requesting any information on child day care service that you provide from your residence. We are always looking for ways to help make our community safer and provide services for the residents who live within the village limits of Bradley. One of those ways is to improve our Sex Offender tracking and monitoring program. As you may know, there are many laws that help us to monitor sex offenders living in the area or attempting to move here. One of those laws is:

720 ILCS 5/11-9.4 (b-5): It is unlawful for a child sex offender to knowingly reside within 500 feet of a playground, child care institution, day care center, part day child care facility, day care home, group day care home, or a facility providing programs or services exclusively directed toward persons under 18 years of age.

This law protects those places listed by prohibiting child sex offenders from living within 500 feet of a residence that provides day care. With this in mind, we are asking for your cooperation in completing the information below that will help us to enforce those laws that keep our children safer and allow us to feel more secure in our own homes.
